It is hereby recognized that all equestrian sports involve inherent risk and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless EC, the OEF, Cadora, Cadora-Ontario, the competition (Glanbrook Cadora), and the site Trinity Trotters Equine, their officials, organizers, agents, employees and their representatives. The person responsible (PR) agrees to the release of any information on the entry form to EC."

All riders, regardless of age or level or competition, must wear ASTM/SEI or BSI/BS EN approved properly fitted and fastened protective headgear at all times when mounted at the Glanbrook Dressage competition at the Center Line Equestrian location. Glanbrook CADORA applies this helmet rule to all its competitions without exception.

"In the event that (**JR. name**) _____ participates in an Equestrian Canada sanctioned competition where protective headgear required for juniors, he/she will wear properly fitted and fastened approved headgear at all times while riding or driving at the event location.
